REGULATIONS

on the holding of the International children's festival «Live! Create! Dream!» for participants from foreign countries VIII shift (from July 14 to August 3, 2025)

Vladivostok, 2025

#### 1. GENERAL REGULATIONS

1.1 These Regulations define the conditions, procedure for organizing and conducting the International children's festival "Live! Create! Dream!" (hereinafter referred to as the Festival).

1.2 The Festival is held by the Federal State Budget Educational Institution "Russian Children's Center "Ocean" (hereinafter - the Center).

1.3 The Festival is held within the framework of the additional general educational program "Children of the World".

1.4 Official information about the program is available on the Center's portal (www.okean.org) in the "Shifts 2025" section.

# 2. AIM AND OBJECTIVES

2.1 The festival is held with the aim of identifying and providing comprehensive support the most talented, creative, promising performers by means of multicultural interaction.

2.2 Objectives:

- To promote respect for the culture of different peoples and nationalities among the young generation of Russia and foreign countries;

- to contribute to the formation of aesthetic taste of the Festival participants on the examples of the best performances;

- to integrate the best international practices of children's creativity among the participants of the Festival;

- to promote friendship between children of different countries.

# 3. PARTICIPANTS OF THE FESTIVAL

Participants of the Festival are students aged 12-17 years old, winners of creative contests of artistic orientation.

# 4. FESTIVAL ORGANIZATION AND HOLDING

4.1 The festival is held in 2 stages:

Stage I - viewing and selection of artistic performances for participation in the festival program;

Stage II - festival program.

4.2 To conduct the Festival, an organizing committee (hereinafter referred to as the Organizing Committee) shall be formed from among the employees of the Center.

4.3 The Organizing Committee shall carry out the following activities:

- receives applications for participation in the Festival;

- performs previews and selection of artistic performances for participation in the second stage of the Festival;

- forms the Festival program and informs the participants about the Festival events;

- determines the format and terms of the events within the framework of the preparation and holding of the Festival;

- organizes the preparation and holding of the Festival;

- promptly informs the participants of the information related to the Festival;

- ensures organization of rehearsals for the participants of the Festival;
- ensures respect for the rights of the participants of the Festival;
- analyzes and summarizes the results of the Festival.

4.4 The Organizing Committee shall decide on the admission of the participants to take part in the Festival.

4.5 The Organizing Committee shall reserve the right to make changes and additions to these Regulations with obligatory informing the participants of the Festival.

# 5. CONDITIONS OF PARTICIPATION IN THE FESTIVAL

5.1 The participants of the Festival are vocalists, instrumentalists, dancers from the Russian Federation and foreign countries.

5.2 Participants of the Festival shall submit an application of the established form for participation in the Festival to the Organizing Committee during the first three days of the shift (Annex).

5.3 All participants of the Festival must have the necessary files on an external flash-USB drive. The audio recording for the performance shall be provided on flash drives to the employee of the Events Department on the day of the art performance viewing. Employees of the Events Department are not allowed to download audio recordings from Yandex Disk, phones, and floppy disks.

5.4 The songs of foreign agents and banned artists in the Russian Federation are not allowed. There is a system of semantic load of the work for the participants of the Festival (translation of songs should be acceptable for children's audience). It is necessary to prepare a translation of the song in the credits for projection on the screen, as well as in the annotation when performing it in one's native language or another foreign language.

5.5 The order of performance of the Festival participants is determined by the Organizing Committee.

5.6 By the decision of the Organizing Committee the Festival participants' performances may not be allowed to participate if the staging, props, costumes do not meet the generally accepted rules and norms of aesthetic perception.

# 6. FESTIVAL NOMINATIONS

6.1 The festival shall be held in the following nominations:

- "National Song";

- "National Dance";

- "Playing a national instrument";

- "Art Song";

- "Modern choreography";

- "Vocal Performance".

#### 7. SELECTION ASSESSMENT CRITERIA

- 7.1 Instrumental performance:
- Technique;
- expressiveness and artistry of performance;
- complexity of the program;
- aesthetics of costumes;
- creative individuality;
- originality.
- 7.2 Vocal performance:
- vocal abilities;
- repertoire selection;
- performance technique (professionalism);
- aesthetics of costumes and props;
- acting skills;
- stage culture;
- originality.
- 7.3 Choreography:
- performing skills;
- musical accompaniment (correspondence of the musical material to the staging of the dances);
- costume design;
- choreography (originality or unconventionality).

#### 8. SUMMING UP AND AWARDING

All participants of the Festival are awarded with participant diplomas.
