REGULATIONS
on the INTERNATIONAL CHILDREN'S ART FESTIVAL
"LIVE! CREATE! DREAM!"

(additional general educational program "Children of the World")

Vladivostok,
2024

General Provisions

1.1 These Regulations define the conditions, organization and conduct of the International Festival of Children's Creativity "Live, Create! Dream!" (hereinafter referred to as the Festival).

1.2 The Festival shall be held by the Federal State Budgetary Educational Institution "Russian Children's Center "Okean" (hereinafter - the Center).

1.3 The Festival is held within the framework of the additional general educational program "Children of the World".

1.4 The aim of the Festival: formation of intercultural competences in the sphere of multicultural education.

1.5 The objectives of the Festival:

- to foster respect for the culture of different peoples and nationalities among the young generation of Russia, Asia-Pacific and CIS countries.
- to display the best international practices of children's creativity and exchange of experience among the participants of the Festival;
- to create favorable conditions for improving the professionalism and quality of performances among performers of vocal, instrumental and dance art;
- to contribute to the formation of aesthetic taste of the participants on the examples of the best performances presented at the Festival;
- to create conditions for the realization of creative abilities of the participants;
- to strengthen friendship between children of the countries of the Asia-Pacific region.

2. Organization and holding of the Festival

2.1 The dates of the Festival: July 14 - August 03, 2024.

2.2 Venue: FSBEI "RCC "Okean".

2.3 An organizing committee (hereinafter referred to as the Organizing Committee) is being formed to hold the Festival.

2.4 The Organizing Committee shall be composed of employees of FSBEI "RCC "Okean"

2.5 The following activities shall be carried out by Organizing Committee:

- to accept applications from the participants of the Festival;
- to form the jury of the Festival (hereinafter referred to as the Jury);
- to determine the format and terms of the Festival
- to form the Festival program and provide information placement for the participants;
- to organize preparation and holding of the Festival;
- to inform the participants promptly of the information related to the Festival ;

- to provide information support of the Festival;
- to provide organization of rehearsals for the Festival participants;
- to ensure observance of the rights of the Festival participants;
- to ensure the preparation of award material and souvenirs, to award the winners and awardees of the Festival;
- to analyze and summarize the results of the Festival.

2.6 The decision on admission of creative groups or individual participants to participate in the Festival shall be made by the Organizing Committee.

2.7 The Organizing Committee reserves the right to make changes and additions to these Regulations with obligatory informing the participants of the Festival.

3. Jury of the Festival

3.1 The Jury of the Festival shall be formed by the Organizing Committee in accordance with the competition nominations of the Festival.

3.2 The Jury of the Festival shall be composed of cultural and artistic figures, representatives of the public, employees of the Center.

3.3 Each member of the Jury evaluates the performance of the contest participant according to a 10-point system, taking into account the criteria as a whole. The decisions of the Jury shall be formalized in a protocol, shall be final and shall not be subject to revision.

3.4 The Jury determines the winners and awardees of the Festival. It is entitled to establish additional special nominations and awards of the Festival.

4. Conditions of participation in the Festival

4.1 The participants of the Festival are vocalists, instrumentalists, dancers from the Russian Federation, Asia-Pacific region, CIS.

4.2 The age of the Festival participants is 12 - 17 years old.

4.3 The application of the established form (Appendix №1) for participation in the Festival shall be submitted by the participants upon their arrival at the Center to the Organizing Committee on the first three days of the shift.

4.4 The members of the Organizing Committee conduct a preview of the Festival participants' performances.

4.5 All participants of the Festival bring necessary files on an external flash-USB media. The phonogram for the performance shall be provided on flash drives to the employee of the

Events Department and holding of events on the day of the preview of the performances. Employees of the Events Department are not to download phonograms from Yandex and Google disks, phones and floppy disks.

4.6 Only music tracks in Russian or that have undergone translation into Russian are allowed. Tracks of foreign agents and banned artists of the Russian Federation are not allowed. There is a system of semantic load of the work for foreign participants (translation of songs must be acceptable at the federal venue). If original material in another language is used, it is necessary to prepare a translation in the credits for projection on the screen, as well as in the annotation.

4.7 The participants of the Festival shall perform compositions on their own musical instruments brought with them. The Center does not provide instruments for the Festival participants, as well as plug-in equipment: "acoustic" and "electrical equipment", switching.

4.8 The order of performance of the Festival participants is determined by the Organizing Committee.

4.9. If the performance, props and costumes of the Festival participants violate the legislation of the Russian Federation and moral norms, these participants may not be allowed to participate in the Festival by the decision of the Organizing Committee.

5. Festival nominations

5.1 The Festival shall be held in the following nominations:

- "National Song";
- "National Dance";
- "Playing a national instrument";
- "Art Song";
- "Modern choreography";
- "Vocal Performance".

6. Evaluation criteria

6.1 Instrumental performance: technique, expressiveness and artistry of performance; complexity of the program; aesthetics of costumes; creative individuality and originality.

6.2 Vocal performance: vocal skills; repertoire selection; performance technique (professionalism); aesthetics of costumes and props; acting skills; stage culture; originality.

6.3 Choreography: performance skills; musical accompaniment (correspondence of the musical material to the staging of the dances); costume design; choreography (originality or unconventionality).

7. Awarding of the Festival participants

7.1 The Jury summarizes the results of the Festival by nominations and special nominations of the Festival.

7.2 The awardees of the Festival in each nomination and in special nominations shall be awarded with diplomas of the Festival awardees and souvenirs.

7.3 The winners of the Festival in each nomination and in special nominations of the Festival shall be awarded diplomas of winners and souvenirs.

7.4 Tutors (teachers), who prepared the winners of the Festival, shall be awarded letters of appreciation.

8. Final provisions

8.1. Issues not reflected in these Regulations shall be resolved by the Festival Organizing Committee, based on its competence within the framework of the current situation, and in accordance with the current legislation of the Russian Federation.
